REPORT

The Committee on Environment and Public Works submits this report to the Senate pursuant to section 302(b) of the Congressional Budget Act of 1974 and section 9(b)(2) of the First Concurrent Resolution on the Budget. Pursuant to the Budget Act, Tables I and II divide among the programs of the Committee's jurisdiction the budget authority, outlays, and entitlements allocated to the Committee by the Budget Resolution for fiscal years 1982 and 1983, respectively. The tables further indicate which of the amounts allocated are controllable (legislation pending) or uncontrollable (current statute).

In accordance with the First Concurrent Resolution, Table III divides among subcommittees the allocation of new direct loan obligations allocated to the Committee for fiscal year 1983.

EXPLANATORY NOTE

Section 302(b) of the Congressional Budget Act of 1974 requires each Committee to subdivide the total allocation made to it contained in the conference report on the First Concurrent Resolution on the Budget. The total allocation assigned to the Environment and Public Works Committee assumes new revenues of \$370 million in fiscal year 1983 through the imposition of user charges.

The Committee wishes to make it clear that the assumptions on user charges contained in the Resolution are not those of the Environment and Public Works Committee. In making its report, the Committee has no choice but to accept the total allocation made to it in the First Concurrent Resolution on the Budget. Inclusion of the revenue entries on user charges in this report does not necessarily constitute an endorsement of the user fees. The Committee reserves the right to consider this issue through the legislative process of hearings and full Committee consideration. In the Committee's view, anything less than complete Committee consideration of this matter would be an abdication of the Committee's responsibilities and an abrogation of the legislative process.

In the March 15 report to the Budget Committee, the Committee assumed that 25 percent of the operations and maintenance costs for inland and harbor navigation projects would be recovered by the Federal Government in fiscal year 1983.

During the first session of the 97th Congress, the Committee reported S. 1692, the National Harbors Improvement and Maintenance Act. Pending on the Senate Calendar, S. 1692 assumes 25 percent cost recovery on port maintenance expenditures.

The Committee is also in the process of evaluating an inland waterway cost recovery bill. Based on the standard established under S. 1692, the Committee has assumed 25 percent recovery on all Federal inland navigation operation and maintenance.
