**A BILL**

To amend section 305 of the Congressional Budget Act of 1974 to require a 60 per centum vote in each House for the passage of a concurrent budget resolution recommending or specifying a budget deficit, or for the adoption of a conference report on such a resolution.

- 1       *Be it enacted by the Senate and House of Representa-*
- 2       *tives of the United States of America in Congress assembled,*
- 3       That section 305 of the Congressional Budget Act of 1974
- 4       is amended by adding at the end thereof the following new
- 5       subsection:
- 6       “(f) SPECIAL REQUIREMENT WHERE CONCURRENT
- 7       RESOLUTION RECOMMENDS OR SPECIFIES BUDGET DEFI-
- 8       CIT.—Notwithstanding any other provision of this Act or

1 of the Rules of the House of Representatives or the Senate,  
2 an affirmative vote of not less than 60 per centum of the  
3 Members of the House involved (a quorum being present)  
4 shall be required for the final passage in either House of  
5 any concurrent resolution on the budget which recommends,  
6 specifies, or would result in a deficit in the budget for the  
7 fiscal year involved, or for the adoption by either House of  
8 a conference report on any concurrent resolution on the  
9 budget which (as set forth in such report) recommends,  
10 specifies, or would result in a deficit in the budget for such  
11 fiscal year, unless such concurrent resolution or conference  
12 report also recommends or provides for the adoption of such  
13 measures, other than increases in the public debt, as may  
14 be necessary to eliminate such deficit.”.
