Emergency Budget Control Act - Authorizes the President, under title X of the Congressional Budget and Impoundment Control Act, to reduce expenditures and net lending in fiscal year 1975 to not less than \$295,000,000,000. Prohibits the reduction of more than 20 percent in the expenditures and net lending of any major department and agency.

A BILL

To authorize the President to reduce Federal expenditures and net lending for fiscal year 1975 to \$295,000,000.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That (a) title X of the Congressional Budget and Impound-
4 ment Control Act of 1974 is temporarily amended to au-
5 thorize the President to reduce expenditures and net lending
6 during the fiscal year ending June 30, 1975, under the
7 Budget of the United States Government to not more than
8 \$295,000,000.
9 (b) No later than thirty days after the enactment of
10 this Act the President shall transmit to the House of Rep-

1 representatives and the Senate a special message specifying the
2 reductions of budget expenditures and net lending for each
3 major department and agency of the Government.

4 (c) In making reductions in expenditures and net lend-
5 ing during the fiscal year ending June 30, 1975, to the
6 figure referred to in the first section of this Act, the President
7 shall not reduce the expenditures and net lending of any
8 major department and agency by more than 20 per centum
9 of the sum requested in the Budget for the fiscal year unless
10 expressly approved by the Congress.

11 (d) The proposal submitted by the President pursuant
12 to this Act shall become law in thirty days following its sub-
13 mission to the Congress unless prior to such date the Con-
14 gress by concurrent resolution disapproves of or modifies all
15 or part of such proposal.
